

# Regulation

The International Academy of Lyric Opera “G. Verdi” organizes master classes for soloists (piano, violin and cello) and chamber music workshop with M° Massimiliano Ferrati, Fabio Paggioro and Luca De Muro, from the 28<sup>th</sup> of July to the 2<sup>nd</sup> of August 2008 at the Alviano Castle.

## 1. General Regulation

**Master classes** are open to pianists, violinists, cellists, ensembles (piano duo, trio, quartet and quintet, strings quartet and quintet). **Chamber music workshop** is open to any student who intend to perfect chamber music repertoire for piano duo and trio playing together with teachers. Candidates from all different nationalities are welcome without age restrictions and they are distinguished between Effective and Auditors. The Academy reserves the right to abbreviate master class period if applications doesn't reach the minimum number necessary.

## 2. Effective students

Candidates who want to be admitted as Effective have to require it sending the application form and the receipt of the application fee payment. If the applications go over the maximum number of students scheduled, Effective participants will be selected by an audition at the beginning of the course with free program which will take place in the morning of the 28<sup>th</sup> of July. For the **Effective soloists** there are three formulas: **Soloists Plus** (4 lessons of at least 90 minutes per lesson), **Soloists Pro** (3 lessons of at least 90 minutes per lesson), **Soloists Light** (2 lessons of at least 90 minutes per lesson). For the Effective Students of **Chamber Music Workshop** there are three formulas: **Plus** (3 lessons of at least 90 minutes per lesson, of which 2 with just a teacher and one with all the teachers), **Pro** (2 lessons of at least 90 minutes per lesson, of which 1 with just a teacher and one with all the teachers), **Light** (1 lesson of at least 90 minutes with all the teachers). For strings quartet and quintet formulas presence of violin and cello teachers is guaranteed for all lessons. For workshop with teachers are scheduled three formulas distinguished by category of piano duo and trio.

## 3. Auditors

Candidates who want to be admitted as Auditors have to require it sending the application form and the receipt of the application fee payment, besides to the candidates who have not passed the preliminary examination.

## 4. Degrees and concerts

At the end of the master class all the students will receive a frequency degree and will have the opportunity to perform in the final concert.
